1. Purpose of Narrowband Transition Plan

The clock ticks on towards the FCC Narrowband Communications requirements by which nearly everyone operating on today's wideband spectrum must be ready to "cut-over" to the mandated narrowband spectrum by midnight December 31, 2012. As demonstrated by the numerous planning meetings conducted by the County Emergency Management Agency staff and the Narrowband Transition Planner, much work has been done to comply with the mandate, yet there is still much work to do. There are licenses that still need to be modified, new licenses to be applied for, equipment to be programmed and new equipment to be purchased to replace non-compliant, outdated equipment.

With this in mind, this Countywide Narrowband Transition Plan is intended to provide each affected public safety agency, school system and health care organization with a picture of where everyone is in the narrowband transition process and to ensure that each of you is ready to "cut-over" on November 1, 2012 to coincide with the State of Maine's narrowband transition date.

2. Planning Process and Plan Development

Androscoggin EMA will host and coordinate the development of the Androscoggin County Radio Communications Narrowband Transition plan. The County EMA Office will also coordinate periodic reviews and updates to the Plan.

Participation, support and approval by a representative of each public safety entity, emergency services entity, schools, healthcare facilities, public works/highway department, parks and recreation, solid waste, sewer and water department is necessary in order to develop and implement this plan.

Periodic surveys will be distributed by the Androscoggin EMA office to each entity listed in order to collect necessary information. It is vital that each entity complete and return this information in a timely manner.

- ☐ The FCC has mandated that all licensees using 25 kHz radio systems migrate to narrowband 12.5 kHz channels by January 1, 2013.
- ☐ The order affects systems on VHF and UHF channels between 150 and 512 MHz
- ☐ Licensees that do not meet the deadline face the loss of license.
- ☐ Application for modification of operations that expand the authorized contour of an existing station using 25 KHz channels will NOT be accepted after January 1, 2011. (Also applies to "new" systems submitted for licensing.)
- ☐ Manufacture and importation of any equipment on 25 KHz channel will NOT be permitted after January 1, 2011.
- ☐ Part 90 "paging-only" frequencies are exempt from this ruling.
- ☐ Low Band VHF systems BELOW 150 MHz are not affected by this ruling.
- ☐ Licensees need to start planning now to migrate to narrowband systems by assessing their current radio equipment and applying for new or modified licenses.
